AFFIDAVIT

1. That my son /daughter has applied and has been offered admission at ITM-Autonomous Institute, Sector-23 A, HUDA, Gurgaon in B.Tech/MTech/MBA _____. His/her AIEEE ROLL NO is _____ and his/her AIEEE Rank is _____ / MAT Score _____ , / GATE Score _____ (as the case may be).
2. That I have read over and understood the rules and regulations of the institute and have executed an Undertaking/Declaration on my own free will and consent along with my son /daughter without any force, fraud and coercion. I and my son / daughter shall abide by the undertaking / declaration and the rules and regulations of ITM-Autonomous Institute failing which the Institute shall be free to take such action as may be decided by the Institute including cancellation of my admission.
3. That I have clearly understood the refund and cancellation policy of the Institute and the financial impact of a mid-course withdrawal on an unaided self finance institution like ITM. In case I fail to do so, besides withholding my no dues clearance/migration/character certificates, the institute shall be entitled to take legal recourse to recover the same at my risk and peril as to costs and consequences.
